



Executive Summary

On May 13, 2024, the Council approved Amundsen Associates with an \$834,600 contract to design the new Community Center. Initially, their proposal covered the survey of the Community Center footprint as outlined in the Request for Qualifications.

Subsequent discussions revealed that the Community Center's footprint would impact nearly the entire city-owned Meadow Acres property, necessitating a replatting. To facilitate this, an expanded survey covering the entire property became necessary.

We requested a quote from Amundsen for this additional survey. Due to their current onsite presence, they offered a favorable quote of \$6,000, which staff considered advantageous.

During the latest weekly meeting, Amundsen confirmed readiness to proceed with the surveying. To expedite the project without delay, the City Manager authorized the comprehensive survey alongside the originally planned work on the Community Center footprint.

Although this expanded survey could have been separately billed due to its broader implications for city interests beyond the Community Center, staff opted to incorporate it into the project scope, necessitating a change order.

ORDINANCE NO. 1043

AN ORDINANCE AMENDING SECTIONS 10.92.070(a) AND 10.52.040
PERTAINING TO THE PARKING OF TRUCKS

WHEREAS, the City of Douglas (City) Council finds and determines that the following changes and clarifications need to be made in regard to the City of Douglas Municipal Code; and

WHEREAS, consideration has been given to ensure fairness to all City of Douglas residents and make new regulations reasonable.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF DOUGLAS, WYOMING:

Section 1. Section 10.92.070 of the Douglas Municipal Code is hereby amended to read as follows:

10.92.070 Truck Parking.

(a) No person shall park any commercial truck over ten thousand (10,000) pounds gross vehicle weight upon any street or alley in the city except in those areas designated as either business or industrial.

Section 2. Section 10.52.040 of the Douglas Municipal Code is hereby amended to read as follows:

10.52.040 Parking of trucks prohibited on certain streets.

There shall be no parking of trucks of any kind on North Third Street between Walnut Street and Center Street or on Brownfield Road. For purposes of this section, "truck" shall not include vehicles of one (1) ton or under.

Ordinance 1043 Amending Ordinances Pertaining to the Parking of Trucks on Brownfield Road.

Recommend approving Ordinance 1043 on first reading.

Executive Summary

Since the adoption of Ordinance 1018 in December 2022, Brownfield Road has had an increase of issues related to parking commercial trucks creating an unsafe and unsightly thoroughfare. Recently, the Douglas Police Department and the Wyoming State Fairgrounds have witnessed damage to fences, an increase in trash being dumped along the side of the road, deep ruts in the drainage area along the west side of the road, and a constant stream of calls to the Douglas Police Department. Additionally, the parking of commercial trucks has created a visual obstruction and an unsafe environment on Brownfield Road.

Public Awareness Campaign: It is recommended that during the process of adopting Ordinance 1043, the Douglas Police Department begin to notify drivers of commercial trucks that parking will be prohibited soon and to start looking for an alternative. Furthermore, it is recommended that once Ordinance 1043 has been published in the Douglas Budget, Public Works distribute temporary signage alerting drivers of commercial trucks that parking is now prohibited anywhere on Brownfield Road.

Background

Ordinance 1018 Amending Sections 10.92.070, 10.04.010(xxxix), 10.52.010(a)(i)(e) And 10.52.040 and Creating 10.48.080 Pertaining to the Parking of Trucks was published December 28, 2022. Specific to Brownfield Road, this Ordinance allowed commercial trucks to be parked on the west side of Brownfield Road between the entrance to the Wyoming State Fair Grounds and the South property line of the Wyoming State Fair Grounds. It also prohibited the parking of commercial trucks on the east side of Brownfield Road.

Water Conservation Solutions for Douglas

Recommendation

Staff's recommendation to help minimize the overuse of the Douglas' potable water system can be broken into three distinctive parts. One, public education and outreach. Two, a quick to activate water use conservation system, and three, the discouragement of water over-use by a tiered rate structure that will allow Douglas to recapture the costs of providing water with our most costly production sources.

- Public Education
 - Public education and outreach will be accomplished through providing information regarding the best times to apply water to landscapes, how to apply an appropriate amount of water to various landscape types, information on how to check for leaking toilets and fixtures in homes, and encouragement of good stewardship of our community resources. This information will be provided to customers through all available media outlets. City stewardship, the City of Douglas will lead by example in being conservative with our water resources. Staff has put together a proclamation recognizing that water is a valuable resource and encourages all of Douglas to become water wise.
- Water Conservation System
 - Having a standardized tiered water conservation system in place for staff to activate quickly in the event of high periods of water consumption, or in the event of the inability to produce an adequate supply of water is critical for the success of our Douglas water system. The conservation system should be broken into four easy to understand tiers as follows:
 - **Voluntary**: Customers of Douglas water system are notified of high-water consumption. All water users are asked to reduce the application of water to landscaped areas or consider watering less frequently. Customers are asked not to water outdoors during the heat of the day (10 a.m. to 6 p.m.)
 - **Moderate**: All water customers are required to reduce the application of water to landscaped areas by 25%. All customers are required to abide by alternate day watering. Properties with even numbers water on Tuesday, Thursday, and Saturday. Properties with odd numbers water on Wednesday, Friday, and Sunday. Public and commercial green spaces water on Monday, Wednesday and Friday.
 - **High**: All water customers are required to reduce the application of water to landscaped areas by 50%. All customers are required to abide by alternate

day watering. Properties with even numbers water on Tuesday, Thursday, and Saturday. Properties with odd numbers water on Wednesday, Friday, and Sunday. Public and commercial properties water on Monday, Wednesday and Friday. Public and commercial green spaces in excess of ½ acre water on Monday and Friday. A 25% water surcharge fee will be applied to all water rate tiers

- **Extreme:** No outdoor watering is permitted. Water use is limited to indoor uses only, unless water use is critical to business operations. A 50% water surcharge fee will be applied to all water rate tiers
- During all tiers of required conservation, the following uses of water are prohibited: Washing of hard surfaces, which include sidewalks, driveways, parking lots, etc., is prohibited except for safety and health considerations. Wasting water by allowing it to run in the street is prohibited. Any watering during the heat of the day (10 a.m. to 6 p.m.) is prohibited.

Water conservation measures shall be memorialized and enacted as necessary and appropriate with the concurrence of the water treatment supervisor and the city manager.

- Tiered Rate Structure
 - The implementation of a permanent tiered rate structure will provide a means for Douglas to discourage the overuse of our potable water system. The intent of the tiered rate structure is to allow flexibility to still encourage growth in Douglas, while providing a revenue stream to allow for improvements within the water system to boost water production and increase resiliency within our water system.
 - The different sources of water for Douglas cost significantly different amounts of money to produce water. The Little Boxelder Spring is the lowest cost, the Sheep Mountain #1 well is of moderate cost, and the surface water plant being the most expensive. Tiered rate structures target the largest consumers of water in the system while leaving the conservative water users relatively unaffected.
 - The Platte River Recovery Implementation Program (PRRIP) has set benchmarks for the quantity of water that can be depleted from the North Platte River system. Douglas has been over our irrigation and non-irrigation benchmarks several times over the last ten years. Douglas has been over the non-irrigation (winter) benchmark more than the irrigation season benchmark. A permanent tiered rate structure will encourage all water customers to be water conscious year around.

WHEREAS, best practices can significantly reduce water usage and runoff while creating healthy lawns, landscaping, and sports turf; and

WHEREAS, the City of Douglas encourages all citizens to monitor their systems for leaks, overspray, and runoff; and

WHEREAS, the City of Douglas further encourages all entities and citizens to conserve water by only irrigating between the hours of 10:00pm and 6:00am.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DOUGLAS, the the City of Douglas, WY be hereby declared to be a "WATER WISE CITY" (#DouglasWaterWise).

FOR THE CITY OF DOUGLAS**

WHEREAS, the City of Douglas recognizes water is a finite resource that is vital to human life; and

WHEREAS, the ability of Douglas to provide its citizens with an adequate supply of drinking water could be hampered if lawn irrigation is excessive; and

WHEREAS, the City of Douglas finds it essential and the highest priority to ensure a proper supply of drinking water to its residents; and

WHEREAS, putting standardized water conservation measures in place will allow staff to activate quickly in the event of high periods of water consumption, or in the event of the inability to produce an adequate supply of water and is critical for the success of our Douglas water system, and

WHEREAS, Section 13.04.020 authorizes the City Manager to implement water conservation measures as necessary, and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL, OF THE CITY OF DOUGLAS, WYOMING, that the following “Water Wise City” Conservation System and measures be established, and may be implemented by the City Manager as necessary and when appropriate, and

- **Voluntary:**
 - Requested to reduce the application of water to landscaped areas or consider watering less frequently.
 - Requested to refrain from watering outdoors during the heat of the day (10 a.m. to 6 p.m.).
 - Requested to refrain from washing hard surfaces, which include sidewalks, driveways, parking lots, etc., except for safety and health considerations.
 - Requested to refrain from allowing water to run in the street.
- **Moderate:**
 - Required to reduce the application of water to landscaped areas by 25%.
 - Required to abide by alternate day watering.
 - Properties with even numbers water on Tuesday, Thursday, and Saturday.
 - Properties with odd numbers water on Wednesday, Friday, and Sunday.
 - Public and commercial green spaces water on Monday, Wednesday and Friday.
 - Required to refrain from watering outdoors during the heat of the day (10 a.m. to 6 p.m.).
 - Required to refrain from washing hard surfaces, which include sidewalks, driveways, parking lots, etc., except for safety and health considerations.
 - Required to refrain from allowing water to run in the street.
- **High:**
 - Required to reduce the application of water to landscaped areas by 50%.
 - Required to abide by alternate day watering.
 - Properties with even numbers water on Tuesday, Thursday, and Saturday.
 - Properties with odd numbers water on Wednesday, Friday, and Sunday.
 - Public and commercial properties water on Monday, Wednesday and Friday.
 - Public and commercial green spaces in excess of one-half (½) acre water on Monday and Friday.
 - Surcharge to water commodity rates of twenty-five percent (25%) for entire month conservation measure is in force.
- **Extreme:**
 - No outdoor watering or water usage is permitted.

- Water use is limited to indoor uses only, unless water use is critical to business operations or safety and health considerations.
- Surcharge to water commodity rates of 50% for entire month conservation measure is in force.

BE IT FURTHER RESOLVED, these measures may be implemented by the City Manager as necessary and when appropriate, and

BE IT FURTHER RESOLVED, other water conservation measures may be enacted at the City Manager's discretion to protect the integrity of the public water supply.

BE IT FURTHER RESOLVED, pursuant to Section 13.16.070 of the Douglas Municipal Code, any violation of water conservation measures is declared to be unlawful, and violation shall be punishable by a fine not to exceed \$750.00.

Recommendation

Accept conceptual design of the Downtown Infrastructure Project 1200 (also known as 1.5 Alley, 2nd & 3rd St. design), and authorize moving forward with Engineering Design.

Executive Summary

This project in the South Downtown area will: replace the old water and sewer mains and address pedestrian traffic as well as address storm water issues, pedestrian lighting, dysfunctional landscaping, and safety.

Project Summary (see attached map)

Water Main Replacement: 2nd St – Elm to Oak; 3rd St – Center to Elm
Sanitary Sewer Replacement: 1.5 Alley – Center to Elm
Street Construction: 1.5 Alley (Center to Oak), 2nd & 3rd St (Oak to Elm),
Street w/Landscaping 2nd & 3rd (Center to Oak)

In addition, close attention will be given to snow removal and street maintenance with this design.

This project aligns with the Master Plan adopted in 2014 and the Downtown Master plan adopted in 2015. With this project, there will be a 4' furniture zone that can be utilized by pedestrian traffic along with a 6" walkway on 3rd street with a larger 11' walkway on 2nd street. ADA curb ramps added to both streets.

Background

The City has been exploring ways to enhance the downtown area's aesthetics, aiming to increase its appeal and visually convey a vibrant, active atmosphere. As part of our master plan, the city council has prioritized investing in downtown by implementing phased streetscaping and utility upgrades.

This project exemplifies our commitment to revitalizing downtown, showcasing our dedication to enhancing community pride. Our goal is to create an enjoyable downtown experience for visitors, highlighting our unique and promotable identity (UPI) through local shops and cultural attractions. Furthermore, research has shown public investment in downtowns will spur private investment in the same space, thus revitalizing downtown, increasing activity, and resulting in economic growth.



The Council approved \$695,000 in funding for the design of this item in the SD2425 Unified Budget & Strategic Doing, with the intention and plan to construct in FY2526. The engineering cost estimate is \$691,282.50. The total project construction cost is projected to be approximately \$5,991,115.

With the new budget year starting we will be looking at designing and advertising for this year's projects soon. We have quite a few projects in this year's budget, and you will see in the coming months those projects in the monthly reports. The below projects are what has been completed and the current projects in design and what will be happening soon.

Clearfield booster is 65% design.

Middle School lift station – This project will be at 90% design in the next two weeks.

Adams St. Project – The water has been installed in the first block. They will be starting on the middle block the week of July 9th.

Landfill Rd. – This project has been awarded to Wayne Coleman construction. We will have a preconstruction meeting on the 9th. The contractor will provide a schedule at that meeting.

N. 4th St. reconstruction is in design.

The Salt/Sand building – The contractor has the concrete wall poured and will be working on the metal portion of the building.

Birch St. sewer project – This project is complete.

2nd and 3rd St sewer replacement project – This project was awarded to Ramshorn Construction; They have started installing sewer pipe on Elm between 2nd and 3rd St.

Washington Park Belmont Stakes Shelter is complete.

City Hall- The City Hall façade and landscaping project is scheduled for a pre-bid meeting on July 2nd with the bid openings on July 9th.

Community Center – The community design team is meeting weekly as of now. Once it is decided that all wants and needs are discussed we will change to bi-monthly meetings.
