PASSED, APPROVED AND ADOPTED THIS 26th day of April, 1993.

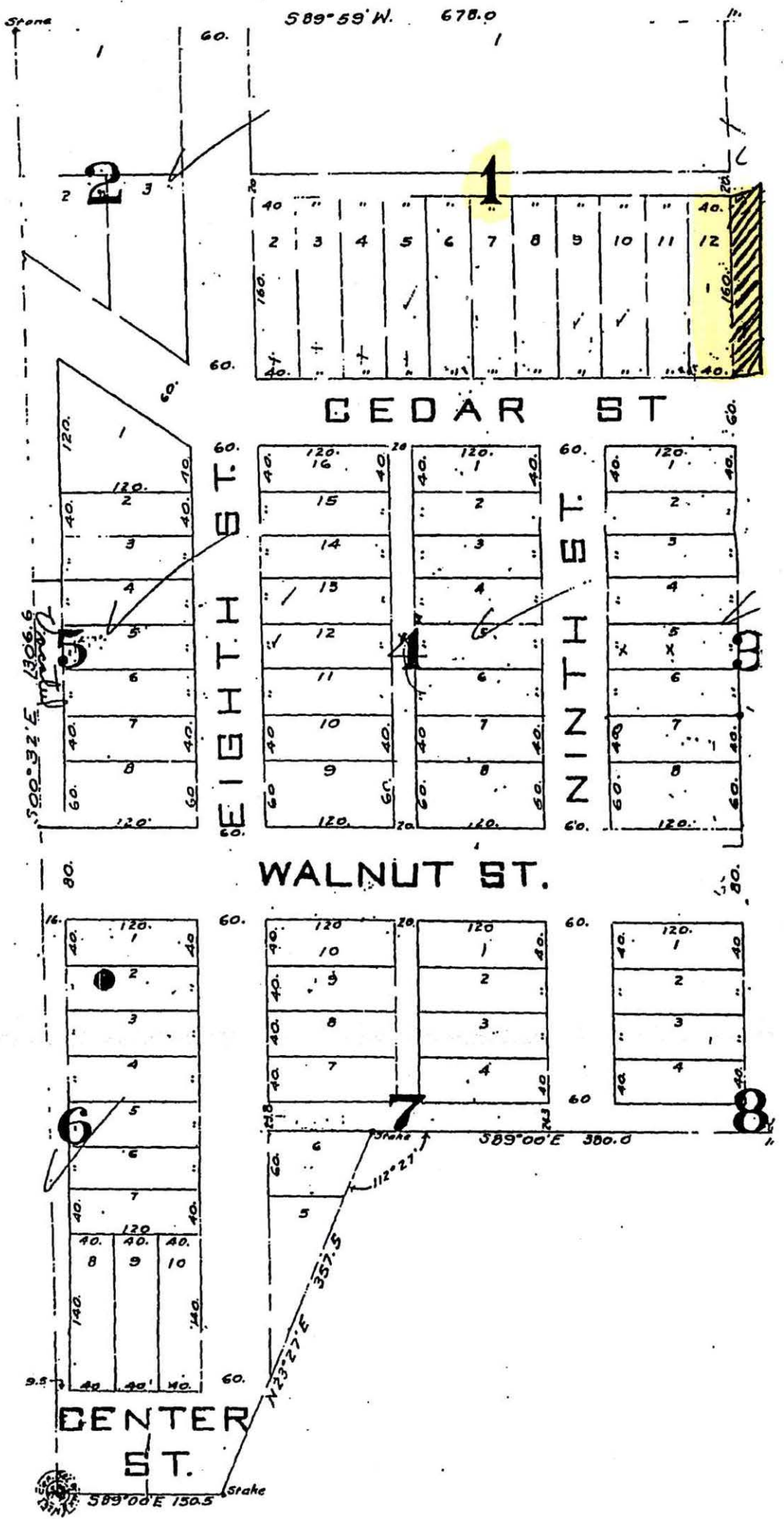

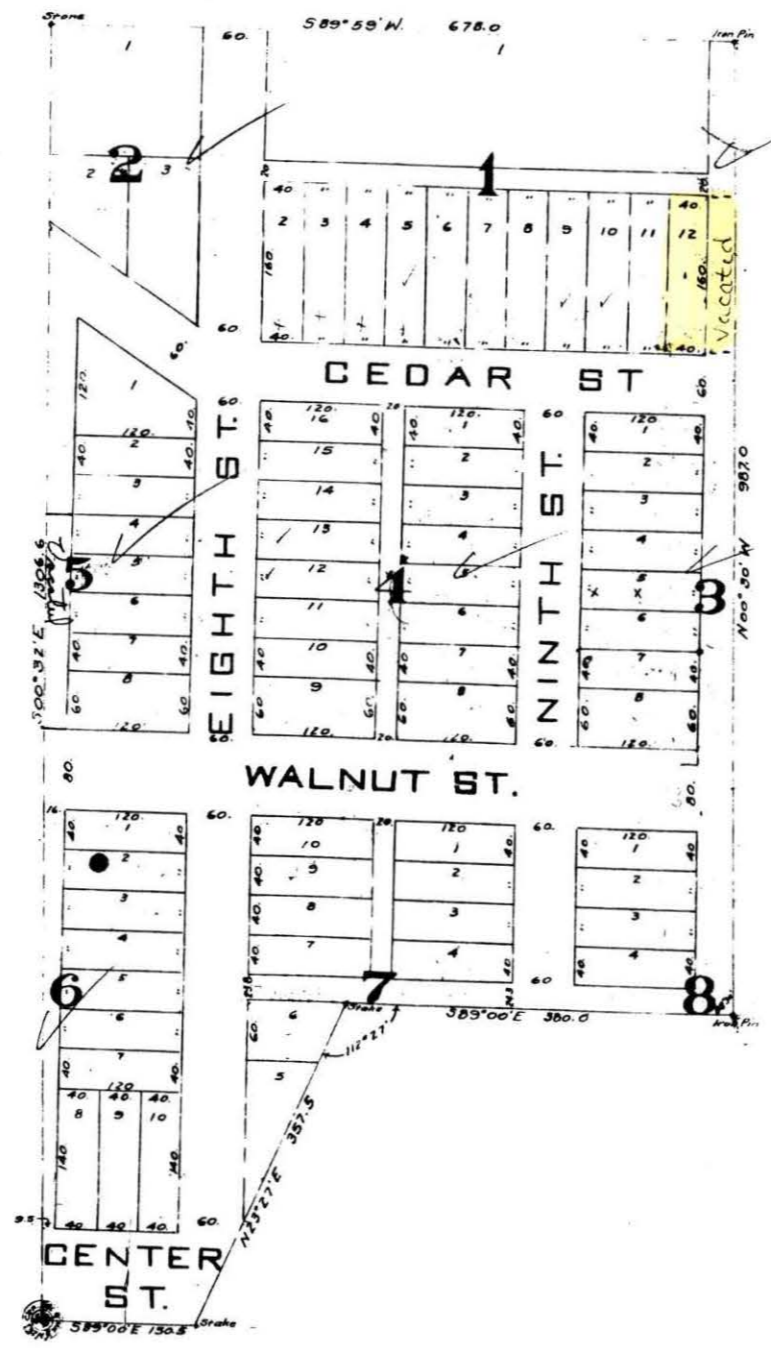
