
ORDINANCE NO. 1016

AN ORDINANCE VACATING THE SOUTH 20 FEET OF THE WEST CLAY STREET RIGHT-OF-WAY FROM WEST GRANT STREET TO THE NORTHEAST CORNER OF RIVERVIEW, LOTS 11 AND 12, BLOCK 3, AND VACATE THE EAST 15 FEET OF THE FIRST STREET WEST RIGHT-OF-WAY FROM WEST CLAY STREET TO WEST POPLAR STREET, DOUGLAS, WYOMING

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF DOUGLAS, WYOMING, that:

WHEREAS, a Petition to Vacate has been submitted by the City of Douglas, requesting the vacation of the south twenty (20) feet of the West Clay Street right-of-way from West Grant Street to the northeast corner of Riverview, Lots 11 and 12, Block 3, and vacate the east fifteen (15) feet of the First Street West right-of-way from West Clay Street to West Poplar Street; and

WHEREAS, the Douglas City Council finds that it is in the best interest of the community to vacate said right-of-way;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF DOUGLAS, WYOMING, that:

Section 1.

That pursuant to the petition by the City of Douglas, and the authority of Wyoming Statutes 15-4-305, 15-6-104, and 34-12-106 through 34-12-108, and Section 16.3.13 of the Douglas Municipal Code, the City Council finds that the vacation of the south twenty (20) feet of the West Clay Street right-of-way from West Grant Street to the northeast corner of Riverview, Lots 11 and 12, Block 3, and vacate the east fifteen (15) feet of the First Street West right-of-way from West Clay Street to West Poplar Street, as described in Exhibit A attached herein, will not abridge or destroy any of the rights and privileges of other proprietors, and further finds that the vacation is in the best interest of the City of Douglas, Wyoming.

Section 2.

That all necessary signatures were dutifully obtained in compliance with Wyoming Statute 15.3.305, attached as Exhibit B.

Section 3.

That the south twenty (20) feet of the West Clay Street right-of-way from West Grant Street to the northeast corner of Riverview, Lots 11 and 12, Block 3, and the east fifteen (15) feet of the First Street West right-of-way from West Clay Street to West Poplar Street, as described in Exhibit A attached herein, shall be vacated, and that said vacated property shall be quitclaimed to the adjacent property owners (who are Echo Stock, Stephen Hipsak Et Ux, Leon Towell, Austin Deines, and Joe Hinckley as of October 24, 2022), upon passage of this ordinance.

Section 4.

The vacated south twenty (20) feet of the West Clay Street right-of-way from West Grant Street to the northeast corner of Riverview, Lots 11 and 12, Block 3, and the vacated east fifteen (15) feet of the First Street West right-of-way from West Clay Street to West Poplar Street shall be replatted and combined with Riverview Subdivision, Block 3: Lots 1,2,3,5, W2 Lots 6 and 7, Lots 11 and 12 and Riverview Subdivision, Block 2: Lots 1 and 14.

Section 5.

That the Clerk of Converse County, Wyoming, in whose office the aforesaid plat is recorded, shall write in plan legible letters across the part of the plat so vacated, the word "VACATED" and also make a reference on the same to the volume and page which the said instrument of vacation is recorded.

Section 6.

The official City of Douglas maps shall be amended to reflect these changes.

Section 7.

This ordinance should become effective after its passage, approval, and publication.

Section 8.

Douglas Municipal Code Sections 1.04.050, 1.04.060, and 2.08.060, by reference, are incorporated herein and made a part hereof.
