Ordinance 1016: Vacation of ROW - 1st St W & W Clay St

Recommendations

Approve petition by the City of Douglas to vacate the south 20 feet of the West Clay Street right-of-way from West Grant Street to the northeast corner of Riverview, Lots 11 and 12, Block 3, and vacate the east 15 feet of the First Street West right-of-way from West Clay Street to West Poplar Street by approving Ordinance 1016 on final reading.

Executive Summary

In May 2022, a developer approached staff about the right-of-way on Clay Street and First Street West bringing attention to the significant amount of undevelopable property in the right-of-way. Working with CEPI, staff determined that 20 feet of the right-of-way on Clay Street and 15 feet of the right-of-way on Frist Street West, could be vacated to the adjacent property owners enabling appropriate residential development.

The Planning and Zoning Commission recommended approval of the petition at the October 17, 2022, meeting.
