Ordinance 1028 – South Douglas Residential Historic District

Recommendation

Consider approval of Ordinance 1028 establishing the overlay zoning district of the South Douglas Residential Historic District to recognize the significance of the neighborhood in representing the history of the growth of Douglas and the architectural trends of our early history.

Executive Summary

3rd Reading: No changes.

2nd Reading: No changes.

1st Reading: In May of this year, the South Douglas Residential Historic District was listed on the National Register of Historic Places including 139 properties, 103 of which are contributing to the district due to their historical significance or architecture. The establishment of the district was a culmination of many years of work by the Douglas Historic Preservation Commission. Creating an official overlay district would designate this area as an historic district in our zoning.

The ordinance creates the Overlay District, defines the purpose and boundaries, encourages preservation efforts, and dedicates the boundaries to the official zoning map. The ordinance does not prevent changes to the structures within the District.

Background

February 2019: Met with Brian Beadles from SHPO to do a preliminary survey and determine if there were adequate properties to justify an historic district and determine proposed district boundaries.

October 2019: Applied for a CLG grant for funds to hire a consultant to do an inventory of the district and establish boundaries of the district and contributing properties.

June 2020: Received the CLG Grant and hired the Rosenberg Consultants to complete the inventory.

June 2021: Phase one was completed, inventory and survey report was completed, boundaries of the district were established, nomination process started.

August 2021: Inventory report submitted.

September 2022: Nomination Documents completed by Rosenberg Consultants with the aid of a CLG Grant from SHPO for the District. The nomination was submitted to SHPO for review and approval then sent to the National Register for consideration.

November 2022: The State recommended submittal to the Nation Register to be reviewed by the National Park Service Board in December.

May 2023: The South Douglas Residential Historic District was listed on the National Register of Historic Places.
